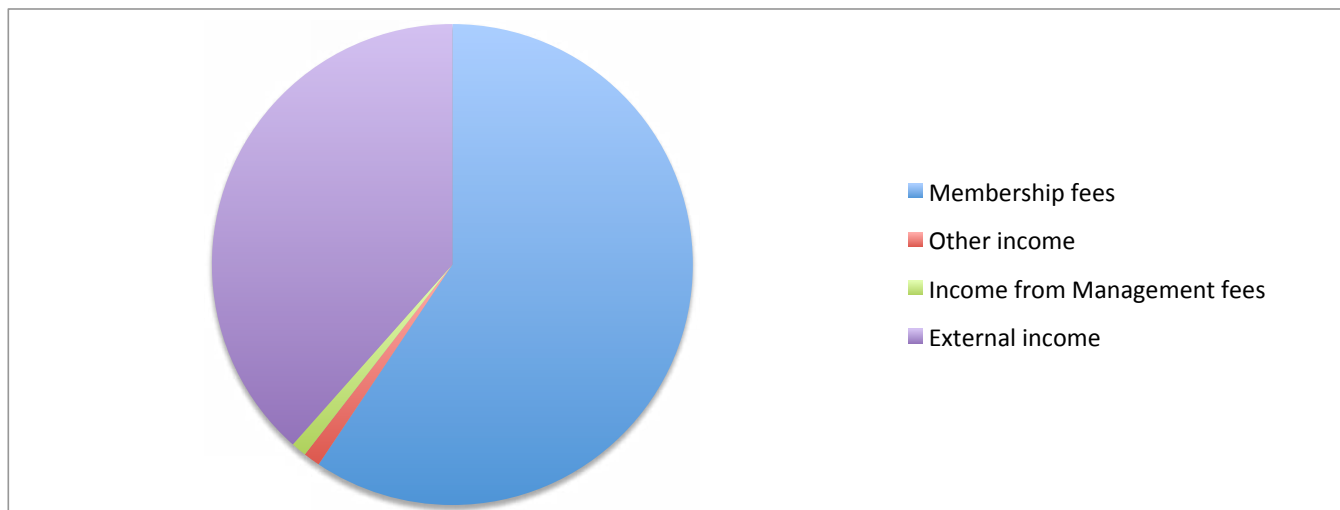

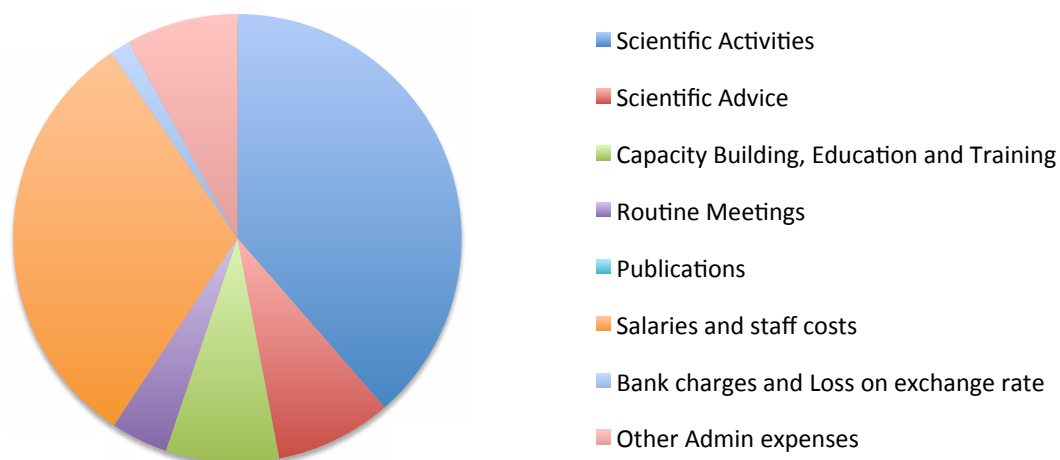

All figures presented have been rounded to the nearest \$ and thus some may show a difference of +1\$ from the 2012 budget

NOTES:

- 1 All money in SCAR bank a/cs on 1.1.2012, except external restricted funds, which are accounted for separately
- 2 Note that since SCAR is now receiving income from several sources but earmarked for specific projects
- so called encumbrances or External Income, these have been separated from income that is available for SCAR to allocate.
- 3 National contributions paid as arrears by Peru, Ukraine and Uruguay
- 4 Administration fees for the Martha Muse Prize. Please note that the Tinker Foundation pay a further \$13,102 towards salary of EO and AA
- 5 Sales include the monies received for purchase of the ACCE report, Science in the Snow and other publications mainly through Google checkout
- 6 CAML project completed in 2010, no further income expected, all remaining monies spent in 2012
- 7 Total Foundation grant has ended, however SCAR continues to manage remaining funds for this project
- 8 Remaining funds paid back to SCAR by UK ISAES organising committee, to be carried forward for 2015 ISAES
- 9 Includes monies for the administration of the 2012 Martha Muse Prize
- 10 The Tinker Foundation 2012 contribution towards salaries of EO and AA
- 11 €7200 expected in 2012, but paid towards this project in 2013, hence considered in Creditors/Debtors line
- 12 Climate Communication project, sponsored by Norway, UK, and ASOC for an update to the ACCE and preparing a report on Climate Communication
- 13 Successful ICSU grant for ISMASS, supplemented by contributions from IASC, IACS, IGS, and SSG-PS
- 14 Each SSG was allocated \$16,000 in 2012
- 15 Each SRP was allocated \$20,000 in 2012
- 16 This SRP ends in 2012
- 17 Even though EBA ends in 2012, it is allowed to carry forward remaining funds upto SCAR Biology, July 2013.
- 18 Co-sponsorship includes payments towards ICED, IPICS, SOOS. It also includes part expenses relating to the Horizon Scanning effort
- 19 Overspend due to high costs associated with SCAR OSC
- 20 Carry forward to 2013 agreed by EXCOM, for workshop in 2013
- 21 Carry forward to 2013 agreed by EXCOM for use for Antarctic Conservation Strategy and Environments Portal
- 22 Carry forward to 2013 agreed by EXCOM, for Visiting Professor Scheme, start in 2013
- 23 Funds allocated but not used, as SCAR OSC LOC provided additional funding for this line
- 24 Overspend due to high costs associated with meeting
- 25 Overspend due to cost of Leadership training for Executive Director (\$ 3353 course fees); additional overtime required by AA
in particular overtime for project Officer originally hired 1 day a week to work on Open Science Conference and SCAR Business Meetings.
- 26 Overspend due to high volume worldwide postage
- 27 Overspend due to high number of claims from EXCOM
- 28 Overspend due to fluctuating \$/£ rate, Negotiated substantial discount for 2012, please note that these fees are
considerably cheaper than other alternatives
- 29 Carry forward to 2013 agreed by EXCOM, for ongoing work on new website
- 30 Includes (II a 6) EBA \$28,319; (II a 17) Ocean acidification \$5,000; (II b 1) SCATS \$5,424; (II c 2) Visiting Professor \$11,000;
(II f 9) Redesign of website \$8,811.60;
- 31 Creditors: Of the grant for ISMASS workshop, EUR 5000 to IACS (\$6,425);
Debtors: €7200 (\$9,252) due from GBIF, this has been paid to SCAR in 2013
- 32 SCAR Reserve is a fund to cover routine meetings and admin expenses for a full year (not exchange rate losses).
It has been calculated as (IId+IIIf) + 10%.
- 33 The contingency fund is the additional funds left to SCAR after committed funds and the Reserve have been taken into account
These funds may be used for one-off expenses or investments with EXCOM/Delegates approval.
